The change allows the weekends as well as the five or more days to be excluded from the calculation of 60 calendar days to complete evaluations. In addition, the rule regarding the timelines for the summer when school is not in session for extended periods is being changed. This change allows that during the summer when staff are not on contract, to be excluded from the 60 day time period as long as the consent to evaluate was received less than 30 days prior to the day teachers are no longer on contract. Systems are still required to complete any evaluation and eligibility for a child turning three during the summer period. An additional change has been made in 6(c)2 to make the language consistent to language in Rule 160-4-7-.05 Eligibility Determinations and Categories of Eligibility to reduce confusion.

Summary Rule 160-4-7-.05 Eligibility Determinations and Categories of Eligibility is being amended to change two categories of eligibility. Specific Learning Disability (SLD) had undergone significant changes with the 2007 rules change as a result of the IDEA changes. The changes in this section alter specific timelines that were delaying evaluations and clarifies requirements for SLD. The previous version required that there be 12 weeks of intervention prior to any determination of eligibility, and that the interventions occur in the current school year. The requirements have been adjusted to remove the requirement for a specific number of weeks of intervention, but instead require that the interventions be administered as the research requires and that data be provided and reviewed. If research does not indicate a specific number of weeks of intervention, a minimum of 12 weeks shall be used. Vision Impairment (VI) has been revised to reflect the definition of vision impaired found in IDEA. In addition, the requirement to have a low vision evaluation has been clarified, making allowances for severity of the disability, the age of the child and the difficulty, at times, to obtain the evaluation in a timely manner.
